Home teams may not change their start times without prior Board Approval. The winning captain is responsible for entering the score online by Monday Morning following the match. The opposing captain is responsible for verifying that the score is accurate online. The Division Chairperson should monitor the standings online for accuracy and expediency.

### **NOTE ON RAIN MAKEUPS:**

If a match is rained out and there is a rain date available for both teams, then the match is rescheduled and lineups are NOT exchanged. If there is NOT a rain date available for both teams, then please exchange the lineups that were ready for the rained out match. In this case, once lineups are entered in TennisPoint you will then hit “Reschedule match” below each line once each match is rescheduled. When you “Enter/edit Scores,” select “not played” for the matches which have no scores yet so that you can enter each line score individually. (This was previously called Rain Mode in TennisPoint.)
